References are made to the announcement of Tanwan Inc. (formerly known as “**ZX Inc.**”) (the “**Company**”) dated July 21, 2025, the circular (the “**Circular**”) of the Company dated July 21, 2025 and the poll results announcement of the extraordinary general meeting (the “**EGM**”) of the Company dated August 8, 2025 in relation to, among other things, the Proposed Change of Company Name and the Proposed Memorandum and Articles of Association (“**M&A**”) Amendments. Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that, following the passing of a special resolution in relation to the Proposed Change of Company Name by the Shareholders at the EGM held on August 8, 2025, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in Cayman Islands, certifying that the name of the Company has been changed from “ZX Inc. 中旭未来” to “Tanwan Inc. 贪玩” on August 8, 2025 (the “**Change of Company Name**”). The Hong Kong Registrar of Companies has issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on August 25, 2025,

confirming that the Company has changed its name and is now registered in Hong Kong under the name of “Tanwan Inc. 貪玩” in accordance with Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

Effect of the Change of Company Name

The Change of Company Name will not affect any rights of the Shareholders nor the ordinary business operation of the Company and its financial conditions. All existing share certificates will continue to be prima facie evidence of legal title to such Shares and continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates for new share certificates bearing the new name of the Company (in both English and Chinese). New share certificates in respect of the Shares will be issued in the new name of the Company (in both English and Chinese).

ADOPTION OF THE SIXTH M&A

The Board is also pleased to announce that, following the approval by the Shareholders by way of a special resolution at the EGM, (i) the Proposed Change of Company Name; and (ii) the adoption of the Sixth M&A which incorporates and consolidates the Proposed M&A Amendments, in substitution for and to the exclusion of the Fifth M&A of the Company, have become effective from August 8, 2025, being the effective date of the Change of Company Name as set out in the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in Cayman Islands.

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “ZX INC” to “TANWAN” in English, and from “中旭未來” to “貪玩” in Chinese, respectively, with effect from 9:00 a.m. on September 2, 2025. The stock code of the Company for trading in the Shares on the Stock Exchange will remain unchanged as “9890”.

ADOPTION OF NEW COMPANY LOGO

The Board is also pleased to announce that the Company has adopted a new company logo to reflect the Change of Company Name with effect from August 28, 2025. The new logo will be printed on relevant corporate documents of the Company, including but not limited to interim reports, annual reports, announcements, circulars, share certificates, and press releases, and will be used on the Company’s website. The new logo of the Company is displayed at the top of this announcement.

CHANGE OF COMPANY WEBSITE

The Board further announces that the website of the Company will be changed from **<https://www.zx.com>** to **<https://www.tanwan.cn>**, effective from September 2, 2025. All announcements, notices or other documents submitted by the Company for publication on the HKEXnews website operated by Hong Kong Exchanges and Clearing Limited will also be published on the new website of the Company.
